#### **Cane Potential**:

Cane availability is near about 5 lakhs M.T. in the area of operation which includes 152 village in Hadgaon Taluka & 71 villages in Himayatnagar Taluka. Irrigation facility is about 75% under the command of U.P.P.Project and 25% on Painganga River, Tube well, Well etc. Major villages are nearby the sugar factory which results in reduced Cane transport cost. The quality of sugarcane is good & consists high sucrose content. Hence recovery is more.
